Backpacking and sea kayaking trip options are available as campers progress through the program. These alternatives fill as campers are accepted. Spaces are limited. Campers not choosing an alternate trip will participate in a canoe trip of appropriate length and challenge.

Porcupine Mountain Backpacking (4-6 nights) - *Must be entering 8th, 9th or 10th grade in fall 2011.*

(2-wk campers enjoy a trip in Porcupine Mtns. for 4-6 nights; 4-wk campers enjoy 6-7 nights in the Porcupine Mtns.)

Sea Kayaking (5-7 nights) - *Must be entering 9th or 10th grade in fall 2011 AND be at least 14 years-old at the session start date.*

LumberJack and LumberJill session options: This is a one-week wilderness trip session option for campers entering 5th-8th grades. Campers will spend one night in a cabin at Manito-wish, four nights on a camping trip, and return to the cabin for the final night of the session.

I understand that in the event of cancellation: **1)** Before February 1, Camp Manito-wish will retain 25% of the full deposit. **2)** Between February 1 and June 1, Camp Manito-wish will retain the full deposit. **3)** In the event of cancellation on or after June 1, dismissal due to misconduct, or withdrawal due to homesickness, Camp Manito-wish will retain 100% of the session fee. If a medical condition (confirmed by a physician) occurs, Manito-wish will retain \$100 and refund the pro-rated balance.
